cannot always call parents to get approval when student safety is at risk

- Kristina (Ms. Yana ASP): Snack during after school needs to improve (juice and crackers everyday), snacks being given are not kid friendly all the time (i.e. spicy snacks)
 - Mr. Owes: talked to an outside provider for better ASP snack options \
- Kristina: Playground spinning contraption unsafe very close to curb
 Mr. Owes: Bark and mulch purchased waiting for delivery, playground did pass safety standards
- Kristina: Area behind playground and other building is unattended
