 - Dr. Kosch gave an update regarding important EPIC news and events such as the CKH Showcase School Visit, facilities update, Think Kindness Challenge, IB PYP Authorization visit, parent conferences and report cards.
- EPIC Data Dashboard/CAASPP Data/RL Data for All Subgroups (including EL)
