 - LCAP Goal 1 was reviewed regarding English Learners. It was determined that based on the I-Ready data, that EL students are making excellent progress based on how EPIC is allocating resources to benefit these students. The SSC/ELAC/DELAC did not recommend any changes to EL instruction/programs at this time. EL progress will be monitored on an ongoing basis by this group. With the recent influx of newcomers, the site council supports any additional para support to assist these students as well as other EL students with designated and integrated ELD.
